

ORDINANCE 2025-3

AN ORDINANCE OF THE BOROUGH OF BENDERSVILLE,
ADAMS COUNTY, PENNSYLVANIA, RE-ENACTING CERTAIN TAXES
UNDER THE AUTHORITY OF THE BOROUGH CODE
AND THE LOCAL TAX ENABLING ACT AND
FIXING THE RATES FOR THE FISCAL YEAR 2026

It is hereby enacted and ordained by the Borough of Bendersville, Adams County, Pennsylvania:

Section 1. That a tax be, and the same is hereby levied, on all real property within said municipality that is subject to taxation, for the fiscal year 2026.

- (a) For general Borough purposes at the rate of 2.5491 mills on each dollar of assessed valuation of the real estate.
- (b) For fire protection purposes at the rate of 0.25 mills on each dollar of assessed valuation of the real estate.

Section 2. The Per Capita Tax is re-enacted and hereby levied at the rate of Five Dollars (\$5.00) on each and every resident and inhabitant of the Borough of Bendersville who is eighteen (18) years of age and older, for general Borough purposes.

Section 3. The Earned Income and Net Profits Tax is hereby re-enacted at the rate of 1.7 percent.

Section 4. The Local Services Tax is hereby re-enacted at the rate of Ten Dollars (\$10.00).

Section 5. The Occupation Tax of 15 mills levied against the Occupation Assessment is re-enacted.

Section 6. Real Estate Transfer taxes are remaining unchanged and are collected by the Recorder of Deeds.

Section 7. The discount, par, and penalty assessments on Per Capita Tax and Real Estate Tax shall conform to the due dates set forth by the County Commissioners of Adams County, Pennsylvania.

Section 8. Repealer. All provisions of previous resolutions and ordinances of the Borough of Bendersville which are contrary to this ordinance are expressly repealed.


Section 9. Savings Clause. In all other respects, the resolutions and ordinances of the Borough of Bendersville shall remain as previously enacted and ordained.

Section 10. Severability. If any word, phrase, sentence, part, section, subsection, or other portion of this ordinance or any application thereof to any person or circumstance is declared void, unconstitutional, or invalid for any reason, then such word, phrase, sentence, part, section, subsection, or other portion, or the proscribed application thereof, shall be severable and the

remaining provisions of this ordinance and all applications thereof, not having been declared void, unconstitutional, or invalid, shall remain in full force and effect.
