

BENDERSVILLE BOROUGH COUNCIL MEETING MINUTES

JULY 26, 2022

CALL TO ORDER by Rick Kime and Pledge Allegiance to the Flag

Present: President: Rick Kime; VPresident: Martha Schriver; Council Members: Pete Stoner, Joe Saum, Jim Bergolios, Scott Howell, Dan Kuhn; Mayor Michael Riley Jr; Secretary: Andrea Rivera; Chief Dennis Pennese; Bob Campbell-Solicitor; Ryan Picarelli-KPI Technology

Minutes: Motion by Pete Stoner, 2nd by Jim Bergolios, all in favor, motion carried, to approve and accept the Minutes of the June 28, 2022.

ADA Curb Ramp Update: No updates were available.

Alley Paving Update: Ryan from KPI sent a breakdown for paving from Recon for each of the streets/alleys in the Borough. Some of the streets/alleys may not need to be done. Council reviewed the information from Recon.

2022 CDBG Grant Application due 8/19/22: Council discussed which streets/alleys to apply for funding to repave with the grant money. After much discussion, it was decided that we would apply for the grant for each of the streets in the Borough. Andrea will proceed with the application.

Fire Company Donation: After much discussion, a motion to give a donation of \$10,000 was made by Joe Saum, 2nd by Jim Bergolios, all in favor, motion carried. Council asked that the check be mailed.

Tax Collection Report: Council reviewed the updated report and had no comments.

397 Potato Rd Water Meter: Council requested a letter be sent to the property owner that any future water meter replacements will be at their expense. Andrea will send the letter.

Police Report/Code Enforcement Report: Chief Pennese attended the meeting to give the report and the code report.

Rick said he and Chief Pennese discussed talking to Menallen about policing some of their area. Several residents in Applewood have requested having someone patrol that area. There would need to be an agreement between municipalities. Mayor Riley wanted to find out the Council's opinion before contacting Menallen Township. Several possibilities were suggested and Rick will contact Menallen to see if they are interested in meeting to discuss at a workshop. We will still need to advertise the meeting. Bob reported that there was a grant started for police recruitment efforts and equipment that we should apply for to help with Police costs. Andrea will start working on an application.

PMCA UCC Report: The report was available for review. Dan requested that Council see pictures of the stone driveway that was put in at 110 N Main St and the sewer pump station was damaged. There was no permit application for the driveway.

Possum Valley Municipal Authority Minutes: The minutes were available for review.

Adams Co Council of Government Minutes: No minutes for review.

Joe Saum: Asked the status of the water shut-offs and collecting past due amounts.

Mayor Mike Riley: Would like to have a representative from Kinsley or Columbia Gas attend a meeting to discuss what they are doing in town and how long will they be working in the Borough. Would like to know if they are replacing concrete the sidewalks where they were digging to replace pipes.
